In March 7, 2022, local farmer Bobby Lewis and Pastors Michael and David Del Vecchio won a big case against the City of Dothan in the Alabama Court of Appeals. The court said the City broke the rules by planning to grow the landfill without holding a public hearing. Now, any future landfill plans must include the public.

The pastors reported that hospital waste, nuclear waste, and other dangerous chemicals have been dumped at the Dothan landfill. They also said old Native American and African-American graves were disturbed when the landfill was expanded.

River Keepers found that the landfill has already harmed our water system. Clean drinking water is vital for everyone in Dothan.

River Keepers have reported that there has been a breach in the aqua system due to the Dothan landfill.
